COURSE DESCRIPTION

Introduction to basic accounting theory and procedures: balance sheet and each of its parts, assets, liabilities, owners' equity, income statement, statement of owners' equity, and the statement of changes in financial position and accounting system. The emphasis in this first course is on procedure, but knowledge of the ruling principles will also be a requirement. (4 units)

- Become familiar with accounting conventions and principles.

In class, I will focus on conceptual and numerical issues, and expect you to pick up the descriptive material from your readings. Reading the chapters ahead of class will help you to ask good questions, and make it easier for you to work on the problems and participate in class discussions. I will assign out of class work at each session. If you are absent, please contact me or a classmate for the next session(s) assignments. Homework is critical to understanding accounting and as such it carries a large component of the grading.
